I am **OPPOSED** to the South East Kelowna Irrigation District proceeding with the borrowing proposal of \$15,300,000 for the SEKID Water Quality Improvement Project.

I, the undersigned, hereby certify that:

- I am a Canadian citizen; and
- I am 18 years of age or older; and
- I am a **landowner** in the South East Kelowna Irrigation District boundaries, or the **authorized agent*** of any Board or Corporation that is an owner of such land; and
- I am not disqualified by the *Local Government Act* or any other enactment or otherwise disqualified by law from voting in local elections; and
- I am entitled to sign this Alternative Approval Process Elector Response form and have not previously signed an Alternative Approval Process Elector Response form for this proposal.

You must meet the requirements above in order to sign this form. Elector Response Forms must have an original signature to be acceptable and may not be submitted by email or facsimile. **See Page 2 for further information regarding petition process.**

INSTRUCTIONS for Elector Response Form

1. If you are **NOT** opposed to the borrowing of 15.3 million for the Water Quality Improvement Project, you need do nothing.
2. If you are **OPPOSED** to the SEKID borrowing 15.3 million for the Water Quality Improvement project you can sign an Elector Response Form if you qualify as an elector. To sign an Elector Response Form you **MUST** be a landowner in the South East Kelowna Irrigation District Boundaries. Proof of land ownership will be verified at the District office. If you are unsure if you qualify, please contact the SEKID office at 250-861-4200.
3. Elector Response Forms are available at the South East Kelowna Irrigation District Office at 3235 Gulley Road, Kelowna BC between 8:30 am and 4:00 pm or on-line at www.sekid.ca or at the informational Open Houses scheduled.
4. A person who obtains an Elector Response Form may make accurate copies of the form, but **NO** faxed or e-mailed forms will be accepted. Forms must have original signatures, and can either be mailed to SEKID attention of the General Manager at PO Box 28064, RPO East Kelowna, Kelowna BC V1W 4A6 **or** dropped off at the SEKID office located at 3235 Gulley Rd.
5. All Elector Response Forms must be received by the South East Kelowna Irrigation District on or before 4:00 pm on **October 25, 2012** to be considered.
6. The number of electors in the South East Kelowna Irrigation District boundaries is estimated to be **3,309**. If ten (10%) percent (**330 electors**) of the estimated number of electors in the South East Kelowna Irrigation District boundaries sign an Elector Response Form **in opposition** to the borrowing SEKID cannot proceed to register a borrowing bylaw with the Ministry without receiving the approval of the electors.
